When a return is processed under your WVA Buying Group Account Number, the credit resides with WVA and you may use it to purchase any optical goods available through WVA.

You will always receive full credit on qualifying returns according to the manufacturers' policies.

MANAGING YOUR WVA BUYING GROUP ACCOUNT

In addition to your customer service support, your WVA representative will help you manage all of your optical purchases. Since your purchases are billed through WVA, they will provide you with monthly reports to help analyze profitability and your overall purchases by vendor.

CONSOLIDATED BILLING — ALL BUYING GROUP VENDOR PURCHASES ON ONE MONTHLY STATEMENT

Pay by check and receive:

- No administration fee
- Full vendor discounts
- No restocking fee on soft contact lens returns
 - WVA contact lens YourRewards

Pay by credit card and receive:

- No administration fee
- Vendor discounts, less 4%
- No restocking fee on soft contact lens returns

*If paying by check, a minimum of \$6,000 in Buying Group purchases is required quarterly with a 3 vendor minimum.

*Soft contact lens sales do not qualify toward the Buying Group minimum.

*Payments must be made in full each month to claim vendor discounts. Delay in payment will result in lost discounts.
